#### Method

Making use of a decoy profile named "Dylan", Army of Angels was able to infiltrate chat-rooms used by predators to exchange child pornography. Working as a group, we have observed, collected and analyzed information regarding the members who most frequently distribute such items.

"Dylan" was created using pictures of a real little boy. A new profile was created and a very small group of people from the group of interest was added by the decoy. After a very short time, "Dylan" already had over 400 friends and messages from adult men, wanting to speak to the child and/or sending indecent photographs of their genitalia. Among these addings, "Dylan" was also added to two groups where child pornography is freely and easily distributed by the members, the most prominent posters to be reported in detail in the images that follow.


This report aims to call the attention of entities, people and/or organizations that can help put an end to the ease with which these people solicit, distribute and download (and even sell) indecent material that involves minors. This is the sad reality of the technological world; platforms such as Facebook are allowing child pornography to be exchanged and, not only making it effortless for predators to exist in this environment but, also, strengthening the idea that pedophilia is generating profit for these platforms. Not wanting to directly accuse, in any way, Army of Angels asks every organization, entity, person or collective that has the power to address this serious epidemic to, please, join your voices in the fight against the untroubled way these items are shared online.


We demand safety for our children and a technology that truly helps to dissipate this extreme situation. These children have no voice – can we give them one?


C) Chats with "Dylan" ("Dylan" never messages first.)






#### D) Post example of what is allowed on Facebook (very graphic)






#### E) Facebook refusals to take down explicit photos involving minors.


This photograph has been circulating on Facebook and it is, clearly, explicit enough to understand what it is. Facebook does not prioritize our MULTIPLE complaints.


We know this is not what you wanted, and we thought it might help if we explain how the review process works.

Our technology helps us review reports first. This means we can find content that goes against our Community Standards quickly and reply to people in a reasonable period of time. Some reports, such as those that might contain child exploitation or suicide, are prioritized for review by our team. Our technology reviewed your report and, ultimately, we decided not to take the content down. If you think we made a mistake, you can request another review. We'll use what you sent us to improve the technology and the reporting experience. Even though the content you reported does not go against our standards, we understand that the content may be offensive or hurtful. Facebook is a global community, and people express themselves differently, so we only take down content that goes against our standards. We review and update our standards regularly, with the help of experts.

Please help us make this cause public, as it is of the interest of the people to know what is going on on the platforms they daily use and the danger our children are in while, innocently, adding profiles that pretend to be children, so they can lure them into the darkest darkness.
